

**Declaration of Conformity – Ventoux Ventilator**

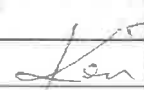

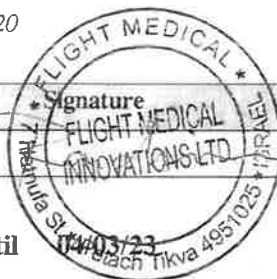

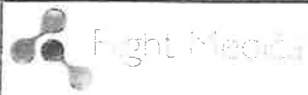
